Victor E. Callahan, Chairman, called the meeting of the Jackson County Legislature to order.

Victor E. Callahan, Chairman, presented a 15 year service pin to Sylvester Booker, an employee from the Assessment Department.

Bob Spence, County Legislator, read a letter from the Raytown School District thanking the Legislature for recognizing the districts "Accredited with Distinction for High Achievement in Performance" rating they received from the Missouri State Board of Education. He mentioned that he, Victor Callahan and Terry Young attended the school board meeting and presented the courtesy resolution from the County Legislature.

5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, mentioned that she attended the Democratic National Convention last week in Los Angeles, California and found it to be very interesting.

She reported that there was a 48-inch water main break last week, the largest in Kansas City history. The Kansas City Courthouse closed at noon on Monday, August 14. A "boil order" was effected even after water service was restored. Bottled water was brought in and provided for employees. She commended staff for their appropriate response to this crisis.

She reported that she would announce the replacement for Sheriff Anderson on Wednesday. Under the Charter, the County Executive must fill the vacancy. The sheriff's replacement must be of the same political party which is Democratic. The voters of Jackson County chose Colonel Tom Phillips at the Primary Election held August 8th. She will make her appointment of Colonel Tom Phillips on Wednesday, August 23 at 10 a.m. in Judge Scoville's Courtroom at the Historic Courthouse on the Square in Independence, Missouri. Judge Ronald Holliger will perform the swearing-in and she invited everyone to attend the ceremony.

She said there will be a bus tour of Jackson County on Saturday, August 26 from 9 a.m. to 2 p.m. sponsored by Jackson County Economic Development Commission. The purpose of this tour is to familiarize the commission with status of current and future business expansions in the County. The tour will include Independence, Lee's Summit, Grandview and Blue Springs. Lunch will be served at 11:30 a.m. at the Eastern Jackson County Administration office at Lake Jacomo.

Finally she reported that Jackson County Parks and Recreation has completed the filming of an orientation video for Missouri Town. The video will be used to enhance the "educational experience" of visitors. Over 100 Parks and Recreation volunteers and staff are featured in period costumes. The video is scheduled for release the weekend of October 7-8 at the Missouri Town 1855 "Fall Festival of Arts, Crafts and Music".
