Finley, County Legislator, said if there are other costs involved which the County is incurring in addition to what is before the Legislature, it is important to advise them of these changes. He explained that this is one reason that an oversight committee has been discussed for this project.

Thomas Kirkwood agreed to keep the Legislature informed during this construction project.
