the nation for African animals and exhibits, a top 10 zoo in the nation for Australian animals and exhibits, and a top 10 zoo for pachyderms: elephants, rhinos, and hippos; and,

WHEREAS, most recently the zoo has been recognized for its world class polar bear and penguin exhibits; and,

WHEREAS, Randy is a Conservation Ambassador for the Missouri Department of Conservation and serves as a board member for the Zoo Conservation Outreach Group and the Convention and Visitors Association of Kansas City, Missouri; and,

WHEREAS, Randy resides in Lee's Summit, MO, with his wife of more than 40 years, Barb; now therefore,
