**INTERLOCAL AGREEMENT  
BETWEEN THE COUNTY OF JACKSON, MISSOURI AND  
THE CITY OF KANSAS CITY, MISSOURI  
THE CITY OF INDEPENDENCE, MISSOURI**

**2017 BYRNE JUSTICE ASSISTANCE GRANT (JAG) PROGRAM AWARD  
Grant Cycle October 1, 2016-September 30, 2020**

This Agreement is made and entered into this 5<sup>th</sup> day of Sept August, 2017, by and between the COUNTY of Jackson (COUNTY), the CITY of Kansas City, Missouri (CITY1), and the CITY of Independence (CITY2),

**WHEREAS**, the U.S. Department of Justice, Office of Justice Programs has collectively allotted \$526,006 to the above-named units of government for state and local law enforcement related initiatives; and

**WHEREAS**, each governing body agrees that the COUNTY of Jackson shall serve as the fiscal agent for the funds; and

**WHEREAS**, each governing body finds that the performance of this AGREEMENT is in the best interest of all parties, that the undertaking will benefit the public, and that the division of costs fairly compensates the performing party for the services of functions under this agreement; and

**WHEREAS**, the COUNTY of Jackson agrees to provide CITY1 \$247,222 from the JAG award for Neighborhoods and Housing Services, Kansas City Police Department, Kansas City Metropolitan Crime Commission, and the Local Investment Support Corporation (LISC); and,

**WHEREAS**, the COUNTY of Jackson agrees to provide CITY2 \$47,341 for the JAG award to purchase Law Enforcement related equipment for public safety; and

**WHEREAS**, the COUNTY of Jackson agrees to \$231,443 from the JAG award for salaries and benefits of staff in the Jackson County Prosecutor's Office; and

**WHEREAS**, the COUNTY of Jackson, CITY1 and CITY2 believes it to be in their best interests to reallocate JAG funds.

**Section 1.**

COUNTY of JACKSON agrees to pay CITY1 \$247,222 of JAG funds.

CITY1 agrees to use the \$247,222 for Neighborhoods and Housing Services, Kansas City Police Department, Kansas City Crime Commission and the Local Investment Support Corporation (LISC).

**Section 2.**

COUNTY of JACKSON agrees to pay CITY2 a total of \$47,341 of JAG funds.

CITY2 agrees to use \$47,341 to purchase Law Enforcement Equipment.

**Section 3.**

COUNTY of JACKSON agrees to receive a total of \$231,443 of JAG funds.

COUNTY of JACKSON agrees to use the \$231,443 for salaries and benefits of staff in the Jackson County Prosecutor's Office.

**Section 4.**

Nothing in the performance of this Agreement shall impose any liability for claims against all participating CITIES under this Memorandum of Understanding.

**Section 5.**

Nothing in the performance of this Agreement shall impose any liability for claims against the COUNTY.

**Section 6.**

Each party to this agreement shall be responsible for its own actions in providing services under this agreement and shall not be liable for any civil liability that may arise from the furnishing of the services by one or more of the other parties.

**Section 7.**

The parties to this Agreement do not intend for any third party to obtain a right by virtue of this agreement.

**Section 8.**

By entering into this Agreement, the parties do not intend to create any obligations express or implies other than those set out herein; further, this Agreement shall not create any rights in any party not a signatory hereto.
