5 COMMUNICATIONS WITH AND REPORTS OF THE COUNTY EXECUTIVE

Phil LeVota, County Executive, was present and gave the following report:

He congratulated the new Chair, Legislator Manuel Abarca IV and Vice Chair, Legislator Sean E. Smith. He also thanked the outgoing Chair, Legislator DaRon McGee for his leadership and professionalism.

The tax bill deadline has been extended until January 31st. Taxpayers can pay, without penalties or late fees, in person, online or by mail with a postmark of January 31. For taxpayers concerned that payments have not yet cleared their accounts, efforts are underway to process payments and there will be no late fees or penalties.

On Monday, January 19th the County offices will be closed in observance of the Martin Luther King Jr. Holiday.

Personal property declarations are due March 1st and you can file online at jacksongov.org

Mr. LeVota has streamlined the process to issue contracts regarding ARPA so that funds are distributed as soon as possible.

Discussion with Legislator Sean E. Smith regarding account updates for taxpayers. Legislator Megan L. Smith, asked for an update on a meeting with the school districts about the State Tax Commission (STC) ruling and possible amendments. The County Executive said he is not pursuing an amendment with the STC. He said the Administration will meet with the other taxing jurisdictions (excluding schools) on January 29th.
