REQUEST SUMMARY	This resolution would approve and authorize the County Executive to sign an Addendum to the Asset Disposition and Sale Agreement with Schneider Industries for the management and sale of additional surplus seats from Arrowhead Stadium. The original twelve-month Agreement was adopted by the Legislature on July 23, 2019. The Addendum extends the agreement for an additional twelve months, and covers all terms and conditions for the second seat sale offering. The Kansas City Chiefs are removing approximately 31,455 seats from the lower bowl, and 2,200 seats from the upper bowl, of Arrowhead Stadium as a part of their planned 2020 stadium renovations. Schneider Industries will perform all work required to take possession of the seats, repurpose them, and make them available to fans and collectors. There are no costs to the County for this project.
