A RESOLUTION transferring \$23,407.00 within the 2013 Anti-Drug Sales Tax Fund to reallocate funds used for the Family Drug Court Program grant.

RESOLUTION NO. 18299, November 12, 2013

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, by Ordinance 4281, dated December 13, 2010, the Legislature did authorize the acceptance of the Family Court Division's Family Drug Court Program grant, in the amount of \$433,312.00, received from the U.S. Department of Justice, for the period of October 1, 2010, through September 30, 2013; and,

WHEREAS, by Resolution 18264, dated September 30, 2013, the Legislature did authorize the extension of the grant through June 30, 2014; and,

WHEREAS, it is desired to reallocate a portion of grant funds for use during the extension period; and,

WHEREAS, the grant requirements allow up to a ten percent reallocation of grant funds without a formal request and approval; and,

WHEREAS, a transfer is necessary in order to place the grant funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends this transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be made within the 2013 Anti-Drug Sales Tax Fund:
