WHEREAS, the Director of Finance and Purchasing has solicited bids on Invitation to Bid No. 25-018 for the furnishing of these products for use by the Department of Corrections; and,

WHEREAS, notifications were distributed, and three responses were received and evaluated from the following:

WHEREAS, following evaluation of the bids submitted, the Finance and Purchasing Department recommends the contract be awarded to the lowest and best bidder resulting in awards to Bob Barker Co. of Fuquay-Varina, NC, Victory Supply of Mt. Pleasant, TN, and Charm Tex of Brooklyn, NY; and,

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay any amount, with the availability of funds for specific purchases remaining subject to annual appropriation, with an estimated annual usage of \$200,000.00; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Department of Finance and Purchasing, and that the Department be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the contracts, to the extent sufficient appropriations to the using spending agency are contained in the then current Jackson County budget.
