TITLE: Awarding a split twelve (12) month term and supply contract with three (3) twelve (12) month options to extend, for the furnishing of T-Shirts & Wearing Apparel for use by various County Departments to EAIS, LLC, of Atlanta, GA; Exhibit Arts, LLC, of Wichita KS; & Sew What?, LLC of Lee's Summit, MO. under the terms and conditions of Invitation to bid 25-050.

SUMMARY: Parks + Rec, Assessment, Public Works, Medical Examiners, & other County Departments all require a term and supply contract for the furnishing of T-Shirts & Wearing Apparel in which bid no. 25-050 was issued. A total of (4,079) notifications were distributed, there were (304) document takers with (18) responses received and evaluated with (5) being rejected due to incomplete responsiveness. The Bonfire Scoring Summary and the using departments Recommendation Memos are attached. Pursuant to Section 1054.6 of the Jackson County Code, the Director of Finance and Purchasing recommends a split award of a twelve (12) month term and supply contract with three (3) twelve (12) month options to extend, for the furnishing of T-Shirts & Wearing Apparel for use by various County Departments to EAIS, LLC, of Atlanta, GA; Exhibit Arts, LLC, of Wichita KS; & Sew What?, LLC of Lee's Summit, MO. These multi venders were all in the top five for Bonfire scoring, can accommodate the wide range of apparel sizes while providing the best pricing. This award is made on as "As Needed" basis and does not obligate Jackson County to pay any specific amount. The availability of funds for specific purchases is subject to annual appropriation. The annual estimated spend is \$95,000.00. The Jackson County Compliance portal was checked and the (3) recommended vendors had a status of "Certificate Issued and Emailed to Vendor" certificate showing 12/31/2026 expiration date.
