REQUEST SUMMARY	On January 29, 2016, the Sixteenth Circuit Court of Jackson County announced the appointment of a new Public Administrator, John P. Killian, to serve for a four-year term. As part of the transition process for a new Public Administrator, the Probate Division of the Circuit Court has ordered that final settlements be filed for the cases under the direction of the prior Public Administrator. The PA's Office requests a six-month Agreement with Rebbecca Lake Wood to complete the filing of these final settlements. Cost would be for approximately 800 cases at \$36.25 each. A transfer from soft saving within the Department's salary budget is recommended to cover the cost of this expense.
