TITLE: Resolution authorizing the County Prosecutor to execute an agreement with the City of Grain Valley, funded through the County's Anti-Crime Sales Tax Fund for the 2025 fiscal year. The agreement includes a twelve-month renewal option and is intended to support anti-crime and anti-violence initiatives and school-based law enforcement activities. The total funding shall not exceed \$75,000.00. Renewal of this contract is contingent upon annual budget appropriations.

SUMMARY:

COMBAT funding is dedicated to building strong and safe communities across Jackson County by addressing the threats posed by illegal drugs and violent crime. This is achieved through a comprehensive approach that includes prevention, treatment services, and support for the criminal

justice system.

This Resolution authorizes the County Prosecutor to execute an agreement with the City of Grain Valley, funded by the County's Anti-Crime Sales Tax Fund, for fiscal year 2025. This agency is engaged in anti-crime, anti-violence and school-based law enforcement initiatives. The funding for this agreement shall not exceed \$75,000.00. The funding category is as follows:

This agreement will include a twelve-month renewal option, contingent upon annual budget appropriations.
