WHEREAS, the Parks + Rec Department has need of golf course landscaping equipment for use at the Fred Arbanas Golf Course; and,

WHEREAS, the Director of Finance and Purchasing has solicited bids on Invitation to Bid No. 24-055 for golf course landscaping equipment for use by the Parks + Rec Department; and,

WHEREAS, a total of seventeen notifications were distributed and viewed, with two responses received and evaluated from the following:

Van Wall Equipment, Inc.

WHEREAS, pursuant to section 1054.6 of the Jackson County Code, the Directors of Finance and Purchasing and Parks + Rec, recommend the award of contracts for purchase of golf course landscaping equipment to Redexim North America, Inc., of Valley Park, MO and Van Wall Equipment, Inc. of Lenexa, KS, as the lowest and best bids received; and,

WHEREAS, a split award is recommended to allow the Parks + Rec Department to get the best price on each item needed; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing, and that the Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all payments, including final payment on the contracts, to the extent sufficient appropriations to the using spending agency have been made in the current Jackson County budget.
