WHEREAS, Jackson County remains second in the number of alcohol-related traffic accidents and first for alcohol related fatalities in the state; and,

WHEREAS, the Missouri Department of Transportation, Highway Safety Division, has awarded the Sheriff's Office a "Sobriety Checkpoint" grant in the amount of \$23,000.00 for the period October 1, 2010, through September 30, 2011; and,

WHEREAS, the Sheriff recommends the use of the grant funds for reimbursement of overtime used for setting up sobriety checkpoints, other alcohol-enforcement related activities, and providing portable heaters and toilets for the checkpoints; and,

WHEREAS, an appropriation is necessary to place the grant funds in the appropriate spending accounts; now therefore,
