ADDENDUM TO AGREEMENT

THIS ADDENDUM TO AGREEMENT, by and between the **JACKSON COUNTY DRUG TASK FORCE**, hereinafter referred to as "JCDF", **JACKSON COUNTY, MISSOURI**, hereinafter referred to as "County", and **BRUCE TRAMMELL**, of Lee's Summit, MO hereinafter called "Officer", is made and entered into this 6 day of April, 2011.

WITNESSETH:

WHEREAS, by Resolution 17231, dated March 29, 2010, the JCDF, County, and Officer did enter into an agreement whereby Officer agreed to provide fiscal services for use by Jackson County Drug Task Force (JCDF), at a cost to the County not to exceed \$15,000.00; and,

WHEREAS, because Officer's relationship with the JCDF is more consistent with the IRS definition of an employee, he will be converted from an independent contract to a part-time employee with the County, beginning April 1, 2011; and,

WHEREAS, by Resolution 17557, dated March 28, 2011, the County Legislature has authorized the Chairman of the JCDF to enter into this Addendum to Agreement to cover the costs of Officer's services from January 1, 2011, through March 31, 2011, at a cost to the County not to exceed \$3,460.80;

NOW THEREFORE, in consideration of the mutual covenants and promises herein contained, JCDF and Officer do hereby additionally agree as follow:

1. Except as hereinafter specifically modified, all of the terms of the prior Agreement between the parties dated April 2, 2010, shall remain in full force and effect and

3. This Addendum to Agreement shall be effective as of January 1, 2011, and shall extend, with the original Agreement, through March 31, 2011.

4. This Addendum, together with the Agreement dated April 2, 2010, incorporates the entire understanding and agreement of the parties.
