Katheryn Shields, County Executive, introduced Sue Levota, Chairman of the Combat Commission. Ms. Levota introduced Ms. Tracey Blaylock, the new Executive Director of the Combat Commission.

Ms. Shields announced that it is time for the Government Employee Food Drive, "Feed the Need", sponsored by MARC and Harvesters. The barrels for food and other items will be in placed in all county departments from June 11 through 29, 2001. She stated that last year Jackson County employees donated 8,676 pounds of food and other items and collected \$1,313.00 to use for food purchases.
