Under the CARES Act, first responder costs such as salaries and benefits of Corrections staff and Medical Examiner staff are fully reimbursable under the provisions of the Act. This ordinance also states the intent of the Legislature to cover all identified needs and costs of the pandemic, but especially building costs to house the Jackson County Health Department after January 1, 2021 with local dollars freed up by charging these costs to the existing CARES allocation.
