TITLE: Awarding a contract to purchase four new vehicles for use by the Drug Task Force from Corwin Motors of Springfield, MO and Corwin Ford Republic of Republic, MO under the terms and conditions of the State of Missouri Contract No. CC240138001-011, an existing competitively bid government contract.

SUMMARY: The Drug Task Force is requesting the purchase of four new vehicles for use by the Task Force for a total cost of \$196,634.

Corwin Motors of Springfield, Missouri, State of Missouri Contract No. CC240138004 responded to the Motor Vehicle Price Quote Request form (PQF) issued by the Drug Task Force with an "off the lot" quoted total price of \$47,700 for a 2025 Jeep Gladiator Sport VIN 1C6PJTAG0SL534181 and \$55,171 for the Dodge Ram 2500 VIN 3C6UR5CJ5SG552575 for the total price of \$102,871.

Corwin Ford Lincoln Republic of Republic, Missouri, State of Missouri Contract No. CC240138003 responded to the Motor Vehicle Price Quote Request form (PQF) issued by the Drug Task Force with an “off the lot” quoted total price of \$48,845 for a 2025 Ford Bronco VIN 1FMEE7BH7SLA6672 and \$44,918 for the Ford Ranger Crew Cab VIN 1FTER4HP2RLE74287 for the total price of \$93,763.

Total cost for the four vehicles is \$196,634.

Pursuant to Section 1030.4 of the Jackson County Code, the Drug Task Force recommends the purchase of the 2025 Jeep Gladiator Sport for \$47,700 and the Dodge Ram 2500 for \$55,171 from Corwin Motors of Springfield LLC, Springfield, MO. In addition, the Drug Task Force recommends the purchase of the Ford Bronc for \$48,845 and the Ford Ranger Crew Cab for \$44,918, from Corwin Ford Lincoln Republic of Republic, MO, under the terms and conditions of State of Missouri Contract No. CC240138001-011, and existing competitively bid government contract. As noted above, Corwin Motors provided the Price Quote Request Form as required by the contact.
