**TITLE:** Awarding a contract to purchase nine new 2025 Dodge Durango vehicles for use by the Sheriff's Office from Reed Motors STJ, LLC dba Reed Chrysler Dodge Jeep Ram of Saint Joseph, MO, under the terms and conditions of State of Missouri Contract No. CC240138010, an existing competitively bid government contract.

**SUMMARY:** The Sheriff's Office is requesting the purchase of nine new 2025 Dodge Durango vehicles at a cost of \$42,711 each. This results in a total cost to the County of \$384,399. Resolution 21609 was adopted May 6, 2024, to purchase nine new 2024 Dodge Durangos and one new 2024 Ram 1500 truck from Reed Motors. The Sheriff's Office immediately notified the dealership that purchase orders would be issued and the dealership advised us that Dodge just closed the 2024 Durango fleet order window. A purchase order for the 2024 Ram 1500 truck was issued as approved, but we were unable to move forward with the 2024 Durangos. Dodge opened the 2025 Durango fleet order window; therefore, we are submitting this purchase request to expend the unencumbered funds. Reed Motors STJ, LLC dba Reed Chrysler Dodge Jeep Ram responded to the Motor Vehicle Price Quote Request Forms (PQF) issued by the Sheriff's Office, as required by the state contract, confirming a total price of \$384,399. Pursuant to Section 1030.4 of the Jackson County Code, the Sheriff's Office recommends the purchase of the nine 2025 Dodge Durangos for a total of \$384,399 from Reed Motors STJ, LLC dba Reed Chrysler Dodge Jeep Ram of Saint Joseph, MO, under the terms and conditions of State of Missouri Contract No. CC240138010, an existing competitively bid government contract.
