<p>REQUEST SUMMARY</p>	<p>The County (by Resolution 19915) and the City of Kansas City, Missouri have expressed a desire to work collaboratively to structure delinquent land tax foreclosure sale procedures which, if successful and implemented, it is believed in many cases would increase the availability of reasonably priced owner's and lender's policies of title insurance for parcels purchased at the delinquent land tax foreclosure sale. The Cooperative Agreement sets forth the terms and conditions for the actions, funding, implementation and evaluation of the structure on a pilot program basis for the 2019 delinquent land tax foreclosure sale, including, without limitation, the contribution of \$90,000.00 by each party and the terms of any RFP for title services.</p>
