All requested inmate clothing samples were compared with the following results:

Charm Tex was chosen for:

- Ladies briefs: They are low bid and similar in quality to the other bidders.
- Socks: They are low bid and the quality is acceptable
- Tennis shoes - men's and women's slip on. They are second to the lowest bid, but much higher quality and will last longer. (These are washed, dried and re-issued).

Bob Barker was chosen for:

- Night shirts: They are low bid and the quality is acceptable.
- Velcro tennis shoes for the Inmate Workers. These were not low bid, but are much higher quality with an arch support and thicker soles. Inmate Workers are on their feet all day on cement floors. (These are washed, dried and re-issued).
- Winter jackets: This was the high bid, but buttons are preferred over snaps as the buttons hold up longer, so the jackets will last longer.
- Sports bras: They are low bid and the quality is acceptable.

Uniforms Manufacturing, Scottsdale was chosen for:

- Men's undershorts: They are low bid and the quality is acceptable
- Men's undershirts: They are not low bid, however these are much higher quality. This is high use clothing, continually being washed and dried. Higher quality will hold up longer.

Shoe Corp, Birmingham was chosen for:

- Shower shoes: They are low bid and all similar in quality.

Robinson Textiles, Gardena CA was chosen for:

- All inmate jumpsuits in all colors. They are low bid and acceptable quality.
