WHEREAS, the COMBAT staff has recommended that \$150,000.00 in Anti-Crime Sales Tax Funds be allocated to the Jackson County Sheriff's Office's 2025 Law Enforcement School Based Initiative program (LESBI); and,

WHEREAS, a transfer within the 2025 Anti-Crime Sales Tax Fund is necessary to cover funding for this program; now therefore,
