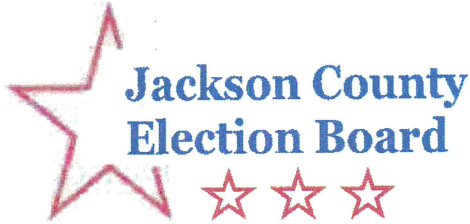

Please find attached reports from the Missouri Centralized Voter Registration System verifying a sufficient number of signatures in the Frank White Jr. Recall.

As of 10:15 a.m. today, June 30, 2025, the number of Valid Signatures for the Jackson County Board of Election Commissioners is 33,838. The Kansas City Board of Election Commissioners report of Valid Signatures is 9,173. Total signatures required for the recall were 42,902 pursuant to the Jackson County Charter representing 20% of the total votes cast for County Executive in 2022. Total valid signatures between the two election boards are 43,011.

It is our intention to keep validating signatures as they come into our office and if your office would like to continue receiving valid signature numbers as they come in, we can provide you with that information.
