TITLE: Awarding a split contract for a Twelve (12) Month Term and Supply Contract with two (2) Twelve Month Options to Extend for the furnishing of grass seed for use by Parks + Rec to Advanced Turf Solutions of Riverside, MO and Swipe Resources, LLC of Burke, VA under the terms and conditions of Invitation to Bid No. 25-043.

SUMMARY: Pursuant to Section 1054.6 of the Jackson County Code, the Parks + Rec Department recommends a split award of a Twelve (12) Month Term and Supply Contract with two (2) Twelve Month Options to Extend for the furnishing of grass seed to Advanced Turf Solutions of Riverside, MO and Swipe Resources, LLC of Burke, VA under the terms and conditions of Invitation to Bid No. 25-043. A total of 1,102 notifications were distributed, forty-three (43) were viewed with four (4) responses received and evaluated. A split award is recommended for Advanced Turf Solutions and Swipe Resources, Inc. being they were evaluated as the lowest qualified bid responses for the specific species of seed needed for the Parks Department. Parks + Rec states an annual estimated usage of \$25,000. The award is made on an "as needed" basis and does not obligate Jackson County to pay any specific
