A RESOLUTION commissioning Daniel Lee Stringer as a park ranger pursuant to section 64.335, of the Revised Statutes of Missouri.

RESOLUTION #17652, August 22, 2011

INTRODUCED BY Fred Arbanas, County Legislator

WHEREAS, section 64.335 of the Revised Statutes of Missouri, authorizes the Legislature to appoint park rangers with the authority to carry firearms within the confines of County parks, in order to furnish security similar to that provided in state parks, so long as each ranger so appointed meets stringent training requirements; and,

WHEREAS, Daniel Lee Stringer possesses the required training and is otherwise qualified to be appointed pursuant to state law; and,

WHEREAS, the appointment of this park ranger pursuant to state law is in the best interest of the health, welfare, and safety of the citizens of the County; now therefore,

BE IT RESOLVED that Daniel Lee Stringer be and hereby is appointed as a park ranger pursuant to section 64.335 of the Revised Statutes of Missouri, with all rights and privileges granted by that section; and,

BE IT FURTHER RESOLVED that the Clerk of the County Legislature be and hereby is authorized to administer the required oath of office to the newly appointed park ranger.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.



All other first class counties in the State of Missouri have commissioned their Park Rangers for the reason of officer safety, patron safety and safety throughout their county parks. The Park Ranger to be presently commissioned is Daniel Lee Stringer.
