INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, the U.S. Department of Justice has awarded the Recovery Act Edward Byrne Memorial Justice Assistance Grant (JAG) to the Jackson County Multi-Jurisdictional Task Force in the amount of \$261,473.68, which the Task Force will use to fully fund four employees and partially fund one employee, with fringe benefits and overtime expenses, to assist in the investigation of federal and/or state criminal charges related to drug-related crimes, for the period of July 1, 2010 through June 30, 2011; and,

WHEREAS, this grant is subject to a local match in the amount of \$104,858.78; and,

WHEREAS, a transfer and appropriation are necessary to place the matching and grant funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said transfer and appropriation; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the

By signing the Award of Contract and Special Conditions for the 2010 JAG Program, the unit of local government (Applicant Agency, hereafter Applicant) enters a binding contract with the Missouri Department of Public Safety to purchase the specific items approved under this contract and perform the services as outlined in the approved application. In accepting this award and JAG program-specific special conditions, the unit of local government and law enforcement agency agrees to the following:

STATE OF MISSOURI / DEPARTMENT OF PUBLIC SAFETY SPECIAL CONDITIONS:

- 1. **RELEASE OF FUNDS:** No funds will be disbursed under this contract until such time as all required documents are signed by the Authorized Official and Project Director and returned to the Missouri Department of Public Safety, Office of the Director for final review and signature by the Director or his/her designee.
- 2. **PEACE OFFICER CERTIFICATION:** The law enforcement agency under this contract assures it is in full compliance with Sections 590.100 to 590.180, RSMo relating to peace officer certification. Section 590.180, RSMo, subsection 2 requires that, "Any law enforcement agency which employs a peace officer who is not certified as required by sections 590.100 to 590.180 or who is otherwise in violation of any provision of section 590.100 to 590.180 shall not be eligible to receive state or federal funds which would otherwise be paid to it for purposes of training and certifying peace officers or for other law enforcement, safety, or criminal justice purposes."
- 3. UCR, RACIAL PROFILING, FEDERAL SEIZURE REPORTING, & CUSTODIAL INTERROGATIONS: The law enforcement agency under this contract assures that it is in full compliance with the provisions of Section 43.505 RSMo relating to uniform crime reporting, Section 590.650, RSMo relating to racial profiling reporting, Section 513.653 RSMo relating to the audit of federal seizures, and Section 590.701 relating to the recording of custodial interrogations. Failure to comply with these sections by the law enforcement agency may result in the withholding of federal funds or termination of this Contract.
- 4. **DUPLICATION OF NETWORKS:** All equipment/software purchased under this Contract must be compatible with the statewide system. All communication devices, if applicable, must be Project 25 (P25) compliant and capable of operating in the trunked mode. Devices which are P25 capable will not be allowed without the proper software to make them compliant.
- 5. **DATA COLLECTION:** To complete and submit any reports required for this program. The reports requested may require reporting on fiscal, operational, and statistical matters. Failure to submit reports by the deadline dates may result in delay for reimbursement requests.
- 6. **ALLOWABLE COSTS:** Only allowable and approved contract purchases can be reimbursed from this account. This fund may not be utilized to pay debts incurred by other activities.
- 7. **ACTIVITIES WITHIN CONTRACT PERIOD:** To purchase or use funds only towards those items approved in the contract application no later than the last day of the contract period. Any deviation from the approved contract must have prior approval from the Missouri Department of Public Safety.

- 8. **EQUIPMENT/FURNITURE:** To submit copies of invoices to the Missouri Department of Public Safety for any equipment/furniture with the monthly expenditure report to verify approved purchases.
- 9. **EQUIPMENT/FURNITURE TAGS:** Any equipment/furniture items purchased under this contract will be used for criminal justice purposes only and must be labeled with an inventory control tag that states the item was purchased with 2010 JAG funds. All items must also be recorded in an inventory control listing.
- 10. **TRAINING:** To submit copies of training certificates (or adequate documentation in the event a certificate is not generated) with the monthly expenditure report to verify the completion of training as funded by the Missouri Department of Public Safety.
- 11. LAW ENFORCEMENT TASK FORCE TRAINING: The law enforcement task force under this contract assures it will complete online training to be provided free of charge through BJA's Center for Task Force Integrity and Leadership. Such training can be accessed at www.ctfli.org and must be completed within 120 days of award (by October 28, 2010). This training is intended for the task force commander, agency executive, task force officers, and/or other task force members of equivalent rank and should be completed by all personnel within the task force. This training will address the task force effectiveness as well as other key issues including privacy and civil liberties/rights, task force performance measurement, personnel selection, and task force oversight and accountability. The task force must submit a copy of the 'Certificate of Completion' to the Missouri Department of Public Safety for each individual whom successfully completed the training.
- 12. **PROGRAM CHANGES:** Notify the Missouri Department of Public Safety on the *Change of Information* form in the event of a change in the Authorized Official, Project Director, Officer in Charge, and/or other program staff approved within the contract.
- 13. **BUDGET CHANGES:** Budget Revisions must be submitted in writing on a *Request to Revise the Budget* form at least 30 days prior to the end of the contract period and at least 30 days prior to the proposed change going into effect. Any budget revisions received less than 30 days prior to the end of the contract will not be reviewed.
- 14. **MONITORING:** All documentation or records relating to this contract shall be made available to monitoring representatives of the Missouri Department of Public Safety, Office of the Director, immediately upon request.
- 15. MITIGATION PLAN: Applicant agrees to fully comply with the Missouri Department of Public Safety's Mitigation Plan for Clandestine Methamphetamine Laboratory Enforcement Operations. No monies from this award may be obligated to support methamphetamine lab operations unless the Applicant agrees to this special condition and fully participates in implementation of the Mitigation Plan.
- 16. **ENFORCEABILITY:** If a Applicant fails to comply with all applicable federal and state requirements governing these funds, the State of Missouri may withhold or suspend, in whole or in part, funds awarded under the program, or recover misspent funds following an audit. This provision is in addition to all other remedies provided to the State of Missouri for recovery of misspent funds available under all applicable state and federal laws.

17. EMPLOYMENT OF UNAUTHORIZED ALIENS PROHIBITED:

- a. Pursuant to §285.530.1, RSMo, the Applicant assures that it does not knowingly employ, hire for employment, or continue to employ an unauthorized alien to perform work within the State of Missouri, and shall affirm, by sworn affidavit and provision of documentation, its enrollment and participation in a federal work authorization program with respect to the employees working in connection with the contracted services. Further, the Applicant shall sign an affidavit affirming that it does not knowingly employ any person who is an unauthorized alien in connection with the contracted services.
- b. In accordance with sections 285.525 to 285.550, RSMo a general contractor or subcontractor of any tier shall not be liable when such contractor or subcontractor contracts with its direct subcontractor who violates subsection 1 of section 285.530, RSMo if the contract binding the contractor and subcontractor affirmatively states that the direct subcontractor is not knowingly in violation of subsection 1 of section 285.530, RSMo and shall not henceforth be in such violation and the contractor or subcontractor receives a sworn affidavit under the penalty of perjury attesting to the fact that the direct subcontractor's employees are lawfully present in the United States.

- 1. **FINANCIAL GUIDE:** The Applicant agrees to comply with the financial and administrative requirements set forth in the current edition of the Office of Justice Programs (OJP) Financial Guide. http://www.ojp.usdoj.gov/financialguide/index.htm
- 2. **CIVIL RIGHTS/EEOP:** The Applicant acknowledges that failure to submit an acceptable Equal Employment Opportunity Plan (if Applicant is required to submit one pursuant to 28 CFR section 42.302), approved by the Office of Civil Rights, is a violation of its Certified Assurances and may result in suspension or termination of funding, until such time as the Applicant is in compliance.

Accordingly, prior to obligating grant funds, the Applicant agrees to first determine if any of the following activities will be related to the use of the grant funds.

The Applicant understands this special condition applies to its following new activities whether or not they are being specifically funded with these grant funds. That is, as long as the activity being conducted by the Applicant or any third party and the activity needs to be undertaken in order to use these grant funds, this special condition must first be met. The activities covered by this special condition are:

- A. New construction;
- B. Minor renovation or remodeling of a property located in an environmentally or historically sensitive area, including properties located within 100-year flood plain, a wetland, or habitat for endangered species, or a property listed on or eligible for listing on the National Register of Historic Places;
- C. A renovation, lease, or any proposed use of a building or facility that will either (a) result in a change in its basic prior use or (b) significantly change its size; and,
- D. Implementation of a new program involving the use of chemicals other than chemicals that are a) purchased as an incidental component of a funded activity and (b) traditionally used, for example, in office, household, recreational, or education environments.
- E. Implementation of a program relating to clandestine methamphetamine laboratory operations, including the identification, seizure, or closure of clandestine methamphetamine laboratories.

Application of This Special Condition to Applicant's Existing Programs or Activities: For any of the Applicant's existing programs or activities that will be funded by these grant funds, the Applicant, upon specific request from BJA, agrees to cooperate with BJA in any preparation by BJA of national or program environmental assessment of that funded program or activity.

- 6. **28 C.F.R. PART 23:** The Applicant agrees to comply with 28 CFR Part 23 if federal funds are used to support Criminal Intelligence Systems.
- 7. **NON-SUPPLANTING:** The Applicant assures that funds received under this contract will not be used to supplant state or local funds, but will be used to increase the amounts of such funds that would, in the absence of federal funds, be made available for law enforcement activities.

- 8. The Applicant agrees to provide information required for any national evaluation conducted by the U.S. Department of Justice.
- 9. **SAFE STREETS ACT:** The Applicant assures that it shall comply, and all its subcontractors shall comply, with the applicable provisions of the Omnibus Crime Control and Safe Streets Act of 1968, 42 U.S.C.
- 10. **DISCRIMINATION:** Federal laws prohibit recipients of financial assistance from discriminating on the basis of race, color, national origin, religion, sex, or disability in funded programs or activities, not only in respect to employment practices but also in the delivery of services or benefits. MISSOURI DEPARTMENT OF PUBLIC SAFETY MITIGATION PLAN

FOR CLANDESTINE METHAMPHETAMINE LABORATORY ENFORCEMENT OPERATIONS

I. Introduction

- A. This plan was developed by the Missouri Department of Public Safety (DPS) in cooperation with the Missouri State Highway Patrol (MSHP) and the Missouri Department of Natural Resources (DNR). The basis for this plan is Missouri's existing Clandestine Drug Laboratory Collection Station program, which was developed by Missouri state and local officials in cooperation with the Federal Environmental Protection Agency (EPA) and the Federal Drug Enforcement Administration (DEA).
- **B.** The scope of application for this plan is all DPS-funded law enforcement operations involving clandestine methamphetamine laboratories (CMLs).
- **C.** The purpose of this plan is to:
 - (1) Coordinate mitigation of the adverse environmental, health, and safety impacts that may arise from law enforcement operations involving CMLs; and
 - (2) Establish the process and points of accountability for ensuring that CML enforcement operations are conducted in compliance with applicable federal, state, and local environmental, health, and safety laws.

II. DPS Accountability

- **A.** On each grant administered by DPS that funds CML enforcement operations, DPS will:
 - (1) Require compliance with this plan as a condition of the grant award; and
 - (2) Monitor compliance with this plan.
- **B.** DPS will administer available grant funds in a manner that facilitates compliance with this plan.

III. Law Enforcement Accountability

A. When a juvenile is discovered at the site of a CML enforcement operation and it is appropriate to place the juvenile into protective custody pursuant to section 210.125, RSMo, a juvenile officer will be immediately contacted and requested to take the juvenile into protective custody to provide for the potential health needs of the juvenile, including medical testing for methamphetamine toxicity and follow-up medical tests, examinations, or health care necessary as a result of methamphetamine toxicity.

- **B.** All personnel participating in the seizure of a CML will receive:
 - (1) Medical screening required by Occupational Safety and Health Administration (OSHA) regulation 29 CFR 1910.120, as applicable pursuant to EPA regulation 40 CFR 311;
 - (2) Initial and refresher training required by OSHA regulation 29 CFR 1910.120, as applicable pursuant to EPA regulation 40 CFR 311;
 - (3) Personal protective equipment required by OSHA regulation 29 CFR 1910.120, as applicable pursuant to EPA regulation 40 CFR 311.

C. Upon the seizure of a CML:

- (1) An EPIC Form 143 will be completed; and
- (2) An initial contamination assessment will be conducted by an individual trained to recognize environmental hazards associated with CMLs. Such training will, at a minimum, consist of training pursuant to paragraph III.G of this plan.
- **D.** If any sign of significant environmental contamination is detected during the initial contamination assessment, a COPS number will be obtained from DEA, and a DEA contractor will be engaged to complete a comprehensive contamination report and to remove all non-evidentiary materials associated with the CML.
- **E.** When a DEA contractor is not engaged to remove materials from the site of a CML enforcement operation, a person trained pursuant to paragraph III.G of this plan will segregate CML materials at the site into:
 - (1) Evidence to be collected; and
 - (2) Non-evidentiary materials to be removed to a collection station authorized and regulated by DNR.
- **F.** The removal of CML materials to a collection station will be performed by a DEA contractor or an individual trained to perform the removal pursuant to paragraph III.G of this plan.
- **G.** The provisions of paragraphs III.C, III.E, III.F and IV.B of this plan will be performed by persons trained to carry out those provisions as follows:
 - (1) An initial 40-hour Clandestine Laboratory Certification Training, or equivalent training;
 - (2) Field supervised training of 24 hours; and

(3) Refresher training of 8 hours annually.

IV. Collection Station Accountability

- **A.** In order to be used under this plan, a collection station must be issued by DPS and authorized for use by DNR.
- **B.** All operations at a collection station will be performed by a person who has received collection station operator training from DNR in addition to training pursuant to paragraph III.G of this plan.
- **C.** All materials removed to a collection station will be segregated by hazard class, packaged, marked, labeled, dated, and processed to determine the appropriate waste stream for disposal.
- **D.** All hazardous waste collected at a collection station will be removed by a licensed hazardous waste hauler under a properly executed manifest and will be transported for disposal at either a Missouri certified resource recovery facility or a temporary storage and disposal facility permitted to accept hazardous waste.

V. DNR Accountability

- **A.** DNR will monitor the transport and disposal components of section IV of this plan for compliance with applicable federal, state, and local law.
- **B.** DNR will provide technical assistance and, as available, financial assistance to maintain collection stations utilized pursuant to this plan.
- **C.** When site contamination is indicated by a comprehensive contamination report completed pursuant to paragraph III.D of this plan, DNR will assess the site for contamination and, if contamination is confirmed, implement the Hazardous Substance Emergency Response Plan portion of the State Emergency Operation Plan pursuant to sections 260.500 through 260.552, RSMo.
