5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, announced the appointment of Ron Bahl as Director of Corrections. She also said that Ken Evans had joined the County as our Public Information Officer and Rob Marek has been appointed Economic Development Administrator.

She said that in the packets the Legislators will have an Ordinance to extend the deadline for submitting the 1999 County budget. Because of the election, the Legislature has until January 31, 1999 to pass a budget. Therefore, the Administration proposes submitting the budget to the Legislature by December 15, 1998. There is also a Resolution to authorize two change orders from Walton Construction Company related to the Detention Center construction project.

Resolution #12424 is in the add-on packet for needed repairs at the Longview and Blue Springs Marinas. Due to the heavy winds last night, the Longview Lake Marina sustained significant damage. Because of the damage, the Administration requests that this Resolution be adopted today so that planned improvements can begin immediately.

Katheryn Shields gave an update on the Records Department. She said a company in Texas will provide data entry on the backlog and the new system is scheduled to be on-line next week.

Dennis Waits requested from the Administration a schedule of the renovation process taking place at the Independence Annex as he has received several calls regarding this matter.

Katheryn said they are having ongoing meetings with the architect and hopefully in a couple of weeks they will have a schedule.

Dan Tarwater said that he and Dixie Flynn had a discussion with Mr. Nunnelly on the urinalysis testing and the bids that went out. They were concerned about the County getting involved in the testing itself because of liabilities.

Katheryn said that our jail staff has never committed and we have told the prosecutor's office we don't want to get in the business of providing testing.

Dan said that we only had one person to bid on it because of the way the bid specifications were written, requesting CEVA equipment.

Katheryn said that she understood the testing was to be done by the Kansas City, Missouri Police Department. She suggested that the Legislature, the current and future Prosecuting Attorney and herself have discussions regarding this subject.
