BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the contract.

FIRST ADDENDUM TO CONSULTING AGREEMENT

THIS ADDENDUM TO AGREEMENT, entered into this _____ day of _______, 2009, by and between JACKSON COUNTY, MISSOURI, hereinafter referred to as "the County," and CLAIRE WEST CONSULTING, LLC, P.O. Box 1044, Jefferson City, MO 65102, hereinafter referred to as "Consultant."

WITNESSETH:

WHEREAS, by Resolution 16656, dated June 16, 2008, the Legislature did authorize the County Executive to execute a Consulting Agreement with Consultant for consulting services for the County's Legislature related to the Jackson County pension plan, at a cost to the County not to exceed \$25,000.00; and,

WHEREAS, by Resolution 16832, dated February 17, 2009, the Legislature authorized the execution of this First Addendum to the Consulting Agreement, extending the agreement through December 31, 2009, at an additional cost to the County not to exceed \$25,000.00; now therefore,

IT IS AGREED by and between the parties as follows:

- 1. Except as specifically provided herein, the Consulting Agreement shall remain in full force and effect pursuant to its terms.
- 2. The scope of work of this engagement shall be modified to encompass those tasks specified on the document attached hereto as Attachment A.
- 3. The total sum to be paid to Consultant is hereby increased in a total amount not to exceed \$25,000.00, payable in four installments of \$6,250.00 each. The Consultant shall submit quarterly invoices to the Legislative Auditor.



- 4. This Addendum shall be effective upon its execution, and shall extend the prior Agreement through December 31, 2009.
- 5. This Addendum, together with the Agreement, constitutes the entire agreement and understanding of the parties.
