AN ORDINANCE appropriating \$33,718.00 from the fund balance of the 2010 General Fund for use by the Circuit Court to cover special prosecutor's fees.

ORDINANCE #4280, December 13, 2010

INTRODUCED BY James D. Tindall, County Legislator

WHEREAS, by order of the Circuit Court, special prosecutors are appointed to handle the prosecution of particular cases, most often when the Prosecuting Attorney's Office has a conflict of interest in the matter; and,

WHEREAS, special prosecutor Charles H. McKenzie has submitted an invoice in the amount of \$52,000.00 for special prosecutor fees which have been found to be reasonable and necessary by order of the Circuit Court; and,

WHEREAS, the budget line item for Special Prosecution has a current balance of \$18,282.00 and an appropriation is necessary to cover the costs in excess of that amount; and,

WHEREAS, the County Executive recommends said appropriation; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:




ORDER FOR SPECIAL PROSECUTOR FEES



MOTION FOR ATTORNEY FEES

COMES NOW Special Prosecuting Attorney Charles H. McKenzie and pursuant to §56.130 R.S.Mo. requests payment of a reasonable fee for his services and the service of Special Investigator James Hess and a reimbursement of necessary expenses in the above-entitled cause. In support of this motion the Special Prosecuting Attorney provides the Court with the following suggestions in support thereof:

1. On February 15, 2008, the Court appointed Charles H. McKenzie as the Special Prosecuting Attorney pursuant to §56.110 R.S.Mo. on the above-entitled cause.
2. On April 16, 2008 James Hess was appointed an investigator for the Special Prosecutor.
3. In furtherance of his duties as Special Prosecutor, Charles. H. McKenzie and Special Investigator James Hess have spent numerous hours and advanced expenses in preparation for the prosecution of this case. A more detailed description of the time spent and expenses incurred is set out in Exhibit A attached.


4. Defendant has been found guilty in a trial of this case and was sentenced to 25 years in the Missouri Department of Corrections on September 2, 2010.

5. A fee of \$150.00 an hour while in trial and \$125.00 for all other time spent for the services provided by Special Prosecutor Charles H. McKenzie and \$60.00 an hour for the services of Special Investigator James Hess are reasonable and customary.

WHEREFORE for the following reasons Special Prosecuting Attorney Charles H. McKenzie hereby requests this Court grant this motion and enter judgment against Jackson County, Missouri in the amount of \$48,091.00 for services rendered and \$8,120.82 to reimburse expenses pursuant to §56.130 R.S.Mo.




