SUMMARY: WHEREAS, Jackson County has an urgent need to fill the positions of Human Resources Director, Finance Director, and Compensation Manager; and, WHEREAS, due to the complex financial and human resources needs of the County, the typical means of recruiting a candidate with the necessary experience have been unsuccessful; and, WHEREAS, the Jackson County Human Resources Department and Finance Department have various duties that require additional staff immediately; and, WHEREAS, OMNI Recruiting will not receive any payment unless viable candidates is recruited and hired by Jackson County; and, WHEREAS, pursuant to section 1030.1 of the Jackson County Code, 1984, the Interim Director of Finance and Purchasing and the County Executive recommend the award of a contract for professional services for use by Jackson County to OMNI Recruiting of Kansas City, MO, as a sole source purchase; now therefore, BE IT
