This Non-Professional Services Contract (this "Contract") entered into this 1st day of April, 2024, by Farber Specialty Vehicles, Inc. (the "Contractor") and the County of Henrico, Virginia (the "County").

WHEREAS the County has awarded the Contractor this Contract pursuant to Request for Proposals No. 23-2578-8JMH, as modified by Addendum No. 1 dated November 2, 2023, and Addendum No. 2 dated November 8, 2023 (the "Request for Proposals"), for Emergency and Specialty Vehicles, Equipment, Accessories, Related Products and Services.

WITNESSETH that the Contractor and the County, in consideration of the mutual covenants, promises and agreements herein contained, agree as follows:

SCOPE OF CONTRACT: The Contractor shall provide the services to the County as set forth in the Contract Documents.

COMPENSATION: The compensation the County will pay to the Contractor under this Contract shall be in Accordance with Exhibit A, "Contractor's Best and Final Offer". If needed, the Commercial List Price may be updated effective each January 1st and June 1st.

CONTRACT TERM: The Contract term shall be for a period of five (5) years beginning April 8, 2024 and ending April 7, 2029. The County may renew the Contract for up to one (1) three-year term and one (1) two-year term, giving 30 days' written notice before the end of the term unless Contractor has given the County written notice that it does not wish to renew at least 90 days before the end of the term.
