<p>REQUEST SUMMARY</p>	<p>The Eastern Jackson County Courthouse at 308 W Lexington is in need of maintenance and repair. The building was built in two phases. The first part was built in the 1948's and the addition was added in 1972's. The 1948's portion is in need of various repairs and maintenance to the exterior to preserve the building. Tuck pointing, brick repair, window caulking, building joint caulking, painting and step replacement are the main items of work. The entire building exterior is to be cleaned and sealed to restore the original appearance and preserve the building.</p> <p>A bid package was prepared and notices were sent to construction contractors and material suppliers. In all, 180 invitations to bid were mailed out. . Additionally, the bid was advertised in the Daily Record, and placed on the Public Purchase Web site.</p> <p>The three contractors that bid on this project are as listed below: Performance Contracting Inc. \$325,376.00 Western Waterproofing Company \$430,822.00</p>												

	Building Restoration Corporation \$538,641.00 Engineers Estimate \$530,000.00 Project scheduled to start this fall and proceed as weather permits. We further request that the Deputy Director of Public Works be authorized to approve adjustments in the construction contract line items, to the extent that there will be no further obligation by the County beyond the contract amount. We, therefore, request that the County Executive be authorized to execute the construction contract with Performance Contracting Inc., for construction of <u>Eastern Jackson County Courthouse Exterior Renovations 2013</u> . We further requests that the Manager of Finance be authorized to encumber \$325,376.00 to cover the cost of the contract.




