WHEREAS, the Sheriff's Office has been awarded additional funds from the Missouri Western Interdiction and Narcotics (MoWIN) Task Force grant in the amount of \$13,022.00 by the Missouri Department of Public Safety; and,

WHEREAS, these additional grant funds help supplement the salary for one deputy assigned to the MoWIN Task Force; and,

WHEREAS, an appropriation is necessary in order to place the grant funds in the proper spending accounts; now therefore,
