

ADDENDUM AND EXTENSION
TO CONSULTING AGREEMENT

THIS ADDENDUM AND EXTENSION TO CONSULTING AGREEMENT is made and entered into on this 20th day of April, 2023, by and between JACKSON COUNTY, MISSOURI, hereinafter called the "County" and FRED DREILING, LLC, 1025 W. 64th Terr., Kansas City, MO 64113, hereinafter called "Consultant."

WITNESSETH:

WHEREAS, via Resolution 20841, dated December 13, 2021, the County did engage Consultant to perform consulting services for the County in the areas of intergovernmental relations, in accordance with the terms, conditions, and covenants as set forth in a Consulting Agreement dated December 22, 2021 ("the Prior Agreement"); and,

WHEREAS, Consultant and County have agreed to extend the Prior Agreement as authorized by Resolution 20841 and to revise a provision of the Prior Agreement;

NOW, THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and Consultant respectively promise, covenant, and agree with each other as follows:

1. Except as specifically provided herein, the Prior Agreement of December 22, 2021, shall remain in full force and effect pursuant to its terms.

2. The sum authorized by paragraph 3 of the Prior Agreement for a subcontract with Bennie Lewis shall instead be authorized for a subcontract with


3. The term of this Addendum and Extension to Agreement shall be effective as of December 1, 2022, and extend until November 30, 2023. Pursuant to paragraph 6 of the Prior Agreement, the parties have the option of renewing the Prior Agreement through November 30, 2024.


4. This Agreement together with the Prior Agreement incorporates the entire understanding and agreement of the parties.




