WHEREAS, pursuant to section 1054.6 of the Jackson County Code, the Director of Finance and Purchasing recommends the award of a twelve-month term and supply contract, with one twelve-month option to extend to Office Products Alliance, of Kansas City, MO, and Rangel Distributing of Kansas City, KS, as the lowest and best responsive bidders; and,

WHEREAS, a split award is recommended to allow using County departments to choose the best submitted quote from the awardees for individual project needs; and,

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay any specific amount, with the availability of funds for specific purchases subject to annual appropriation, with an estimated annual usage of \$250,000.00; now therefore,
