## 5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, recognized Prosecuting Attorney Bob Beaird and Michelle Peden, Office Administrator in the Prosecutor's Office. She announced that Ms. Peden is the employee of the month for March, 2001. Michelle put together a comprehensive orientation for new employees and in the process she taught herself a new computer program. On behalf of the taxpayers of Jackson County, Katheryn Shields thanked Michelle for her public service and presented her with a certificate, a pin, and a \$100.00 check. Brief comments were made by Prosecuting Attorney Bob Beaird.

Katheryn Shields reported that reappraisal notices are currently being mailed. This is a state-mandated reappraisal and it covers 269,981 real estate parcels including residential, agricultural and commercial in Jackson County. All taxpayers will receive a notice even if their values did not change. In 2001 the average increase is 4.4% and the highest is 12%.

Ed Severeid, Director of Assessment, said that all appraisals should be mailed out by Wednesday, May 2, 2001. Taxpayers who have questions or wish to appeal to the Board of Equalization can call 881-4601. He said information is printed on the notice and is also available on the Jackson County web site at www.jacksongov.org. Mr. Severeid explained that the reappraisal notice includes the 2001 market value, 2001 assessment and the 2000 assessment.

Victor E. Callahan, Chairman, said as he was touring the old courthouse on the square in Independence he noticed the stairs to the building were deteriorating and in need of repair. He also learned that an election worker had fallen on the stairs. He asked if the sidewalks and stairs around the old courthouse will be repaired soon and have we included money to make these repairs.

Katheryn Shields said she will ask Facilities Management to look into this problem and will report back to the Legislature at their next meeting.

Terry Young, County Legislator, asked Ken Evans, Public Information Officer, how the tape would be delivered to the City of Raytown since they have agreed to televise the County Legislative meetings.

Ken Evans responded that Office Services will deliver the tape to Raytown, MO on Tuesday mornings and the meetings will be broadcast on Wednesday and Friday. He will report the airing times at a later date.
