AN ORDINANCE appropriating \$10,000.00 from the undesignated fund balance of the 2024 Grant Fund in acceptance of funding provided by the Organized Crime Enforcement Task Force, for use by the Jackson County Drug Task Force for "Operation Twisted Tiger."

ORDINANCE NO. 5827, February 19, 2024

INTRODUCED BY Venessa Huskey, County Legislator

WHEREAS, the Jackson County Drug Task Force (JCETF) and the U.S. Drug Enforcement Administration (DEA) have formed the Organized Crime Drug Enforcement Task Force (OCDETF) to conduct a joint federal drug investigation, OCDETF Case No. WC-MOW-0384, "Operation Twisted Tiger"; and,

WHEREAS, a portion of the overtime costs incurred by the JCETF for this investigation will be reimbursed by the OCDETF, in an amount not to exceed \$10,000.00; and,

WHEREAS, an appropriation is necessary to place the projected funds in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation from the undesignated fund balance of the 2024 Grant Fund be and hereby is made:
