SUMMARY: The Human Resources Department requires a Term and Supply Contract for the furnishing of Broker Services for its Workers' Compensation and Excess Liability Insurance. The Purchasing Department issued Invitation to Bid No. 24-067 in response to those requirements. A total of 505 notifications were distributed, 27 viewed and 3 responses were received and evaluated. Pursuant to Section 1054.6 of the Jackson County Code, the Purchasing Department and the using Departments recommend the award of a Twelve (12) Month Term and Supply Contract with One (1) Twelve (12) Month Option to Extend for the furnishing of Workers' Compensation and Excess Liability Insurance for use by Human Resource Department to Cowell Insurance Solutions (CIS) of Overland Park, Kansas as the lowest and best bid under the terms and conditions of Invitation to Bid No. 24-067. Annual Estimated Usage: \$15,000 This award is made on a "As Needed" basis and does not obligate Jackson County to pay any specific amount. The availability of funds for specific purchase(s) is subject to annual appropriations.
