**A RESOLUTION** awarding a twelve-month term and supply contract, with two twelve-month options to extend, for the furnishing of pavement marking services for use by various County departments to Streetwise, Inc. of Grandview, MO, under the terms and conditions of Invitation to Bid 25-024.

WHEREAS, various County departments are in need of pavement marking services for on-going roadway construction projects; and,

WHEREAS, pursuant to Invitation to Bid 25-024, the Director of Finance and Purchasing has solicited bids for the furnishing of pavement marking services for use countywide; and,

WHEREAS, thirteen notifications were distributed, and one bid was received and evaluated from Streetwise, Inc. of Grandview, MO, and,

WHEREAS, the Director of Finance and Purchasing recommends that the contract be awarded to Streetwise, Inc. of Grandview, MO, under the terms and conditions of Invitation to Bid 25-024, as the lowest and best bidder; and,

WHEREAS, this award is made on an as needed basis and does not obligate the County to pay any specific amount, with the availability of funds for specific purchases being subject to annual appropriation, with an annual estimated usage of \$325,000.00; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing, and that the Director be and hereby is authorized to execute for the County any documents necessary for the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent that sufficient appropriations to the using spending agencies are contained in the then current Jackson County budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
