

**ADDENDUM TO**  
**AGREEMENT FOR DISTRIBUTION OF CARES ACT FUNDS**

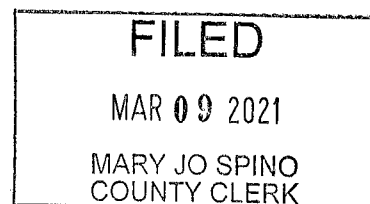
THIS FIRST ADDENDUM, made and entered into on this 9<sup>th</sup> day of March 2021, by and between the undersigned Jackson County, Missouri ("County"), and the undersigned Recipient ("Recipient") an entity which operates within said County (collectively the "Parties").

WHEREAS, the County and Recipient entered into an Agreement for Distribution of CARES Act Funds dated September 17, 2020 ("the Prior Agreement"), whereunder County agreed to provide for reimbursement of certain COVID-19 related expenses; and,

WHEREAS, the parties now desire to extend the Agreement for an additional twelve-months at no additional cost.

NOW, THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and Recipient respectively promise, covenant and agree with each other as follows:

1. Except as expressly provided herein, all provisions of the Prior Agreement shall remain in full force and effect pursuant to its terms.
2. This First Addendum to Agreement together with the Prior Agreement shall be extended to December 31, 2021.
3. The First Addendum shall be effective as of December 31, 2020, and shall remain in effect, together with the Prior Agreement, until December 31, 2021.
4. This First Addendum to Agreement together with the Prior Agreement, incorporates the entire understanding and agreement of the parties.

ORDINANCE NO. 1996

AN ORDINANCE APPROVING AN ADDENDUM TO AGREEMENT FOR DISTRIBUTION OF CARES ACT FUNDS WITH JACKSON COUNTY, MISSOURI, AND AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT.

WHEREAS, on September 8, 2020, the Board of Aldermen adopted Ordinance No. 1983 approving a County Agreement for Prepayment Distribution of CARES Act Funds and authorized the Mayor to execute the agreement on behalf of the City; and

WHEREAS, on September 17, 2020, the City and Jackson County, Missouri entered into said Agreement; and

WHEREAS, the City and the County desire to extend the term of said Agreement in order to facilitate any potential future allocation of funds from the United States government to the County for the purposes included in said Agreement; and

WHEREAS, the City is authorized to enter into cooperative agreements with other governmental entities pursuant to Sections 70.210 to 70.320 RSMo; and

WHEREAS, Section 70.230 RSMo provides that the City may enter into such cooperative agreements by ordinance duly enacted.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN FOR THE CITY OF OAK GROVE, MISSOURI, AS FOLLOWS:


SECTION 1. That the Addendum to Agreement for Distribution of CARES Act Funds between the City of Oak Grove, Missouri, and Jackson County, Missouri, attached hereto as Exhibit A and incorporated herein by reference, is hereby approved and the Mayor is authorized to execute said Addendum on behalf of the City of Oak Grove, Missouri.

SECTION 2. That all ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.


SECTION 3. That this ordinance shall be in full force and effect from and after the date of its passage and approval.

Read two times and passed by the Board of Aldermen of the City of Oak Grove, Missouri, this 1st day of February, 2021.


