WHEREAS, Mary Jo's passion for her work in the community and for the County is evident to her co-workers and associates who interact with her each day; and,

WHEREAS, in addition to playing bocce ball, Mary Jo enjoys traveling and the theater as well as attending her son Nico Brogoto's high school football games at St. Pius X, and spending time with her daughter, Michaela Brogoto, a junior at the University of Missouri Kansas City, pursuing a career in dentistry; now therefore,


