

**FIRST ADDENDUM TO AGREEMENT**

**THIS FIRST ADDENDUM TO AGREEMENT**, made by and between **JACKSON COUNTY, MISSOURI**, A Constitutional Home Rule Charter County of the First Class of the State of Missouri, hereinafter referred to as "the County," and **CATHOLIC CHARITIES OF KANSAS CITY - ST. JOSEPH, INC.**, 20 W. 9<sup>th</sup> Street, Kansas City, MO 64105, a Missouri not-for-profit corporation, hereinafter referred to as "Contractor."

WHEREAS, by Resolution 17009 dated September 21, 2009, the County and Contractor did enter into an agreement whereby Contractor agreed to provide services under the terms and conditions of the Homeless Prevention & Rapid Re-Housing Program (HPRP) Grant, at a cost to the County not to exceed \$58,550.00; and,

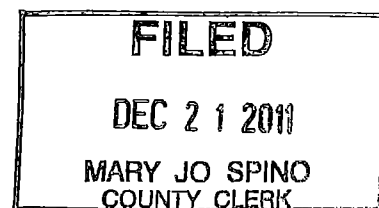
WHEREAS, the parties now desire to extend the contract at an increased cost; and,

WHEREAS, by Resolution 17728, dated November 7, 2011, the Legislature did authorize the County Executive to extend the Agreement with the Missouri Department of Social Services for the HPRP Grant, for the period of October 1, 2011 through July 22, 2012; and,

WHEREAS, Resolution 17728 also authorized the County Executive to enter into this First Addendum to Agreement;

NOW THEREFORE, it is agreed by and between the parties as follows:

1. Except as expressly provided herein, all provisions of the prior Agreement between the parties approved by Resolution 17009, dated September 21, 2009, shall remain in full force and effect and the terms and conditions thereof are incorporated



herein by reference.

2. The maximum sum to be paid by County to Contractor under this First Addendum shall be a total amount not to exceed \$40,740.00.

3. Contractor shall abide by the following terms and conditions as set forth in the County's HPRP Grant Agreement with the Missouri Department of Social Services:

- a. Services provided under this contract extension shall end by May 31, 2012.
- b. Invoices for services provided through May 31, 2012, shall be submitted to County by June 7, 2012. Invoices received after June 7, 2012 will be rejected and returned to Contractor.
- c. Contractor shall invoice for services by January 6, 2012, at least 40 percent of its additional funds, or \$16,296.00, to avoid possible reallocation of HPRP Grant funds by the Missouri Department of Social Services.

4. This First Addendum, together with the Agreement, shall extend through July 22, 2012.

5. This First Addendum, together with the agreement approved by Resolution 17009 dated September 21, 2009, incorporates the entire understanding and agreement of the parties.


