**TITLE:** Appropriating \$935,000 from the undesignated fund balance of the Grant Fund for two (TAP) Transportation Alternative Program Grants administered by MoDOT. Little Blue Trace and Rock Island Connector Trail

**SUMMARY:** A funding agreement has been executed between MoDOT and Jackson County by resolution 20870 on February 22, 2022, for four hundred seventy-five thousand dollars and zero cents (\$475,000) using Transportation Alternative Program (TAP) funds. A supplemental funding agreement between MoDOT and Jackson County by resolution 21710 on September 9, 2024, for four hundred sixty thousand dollars (\$460,000) using Transportation Alternative Program (TAP) funds. Appropriation in the amount of \$935,000 is necessary to place the grant funds in the proper spending accounts. The award of construction contract to MegaKC was approved by ORDINANCE NO. 6004 on September 22, 2025, funding the construction contract for \$2,870,540 using funds from 013-1608-58060. \$935,000 less is needed from 013-1608-58060 once the \$935,000 is appropriated to the grant account for this project. With approval of this legislation, the MegaKC contract will be funded at \$1,935,540 from 013-1608-58060 and \$935,000 from 010-1608-58060.
