WHEREAS, the overtime costs incurred by the JCDTF for this investigation will be reimbursed by the OCDETF, in an amount not to exceed \$7,500.00; and,

WHEREAS, an appropriation is necessary to place the projected funds in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation from the undesignated fund balance of the 2013 Anti-Drug Sales Tax Fund be and hereby is made:
