WHEREAS, the Director of Parks and Recreation has recommended that the County execute the attached permanent easement with the City of Lee's Summit for the installation of a sanitary sewer force main; and,

WHEREAS, the City has agreed to pay the County easement and processing fees required by the County Code, totaling \$6,683.80, and

WHEREAS, the execution of the attached easement and supporting documents is in the best interests of the health, welfare, and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the attached Permanent Easement is hereby approved and that the County Executive is

hereby authorized to execute on behalf of the County the Agreements and any other documents necessary to give effect to this Resolution.

GRANTOR further states that it is lawfully seized of title to the land through which said easement is granted and that it has good and lawful right to convey said easements to the **Grantee** herein.

GRANTOR, to the fullest extent allowed by law, including, without limitation, section 527.188, RSMo. (2006), hereby waives any right to request vacation of the easement herein granted.

THIS GRANT and easement shall, at all times be deemed to be and shall be, a continuing covenant running with the land and shall be binding upon the successors and assigns of the **Grantor**.

TO HAVE AND TO HOLD THE SAME, together with all appurtenances and immunities thereunto belonging or in any way appertaining, unto the City of Lee's Summit, Missouri, a Municipal Corporation, and to its successors and assigns forever.
