WHEREAS, Ms. McConnell started as a clerk in Real Estate Assessment on September 5, 1974; and,

WHEREAS, Ms. McConnell moved on to the position of Secretary II in the Assessment Department on June 19, 1976, and then Secretary III on of May 7, 1979; and,

WHEREAS, Ms. McConnell advanced to Secretary on June 23, 1982; and,

WHEREAS, Ms. McConnell in September 3, 1984, moved to the Collections Department as Clerk 5 where she stayed in this position until August 19, 1985; and,

WHEREAS, Ms. McConnell in February 17, 1986, arrived at the Legislature as a Clerk typist, then on June 29, 2001, she advanced to Legislative Secretary, where she remained in this position until her retirement on December 31, 2016; and,

WHEREAS, upon retirement Ms. McConnell served 42 years with Jackson County

returning on January 23, 2017, to work part-time as an Administrative Assistant for the Legislature; and,

WHEREAS, on February 5, 2024, Ms. McConnell moved into the County Clerk's Office as an Administrative Assistant and has remained in the Clerk's Office to date; and,

WHEREAS, Ms. McConnell is always willing to help and assist wherever she is needed and gives willingly to those who need her; and,

WHEREAS, Ms. McConnell is a community volunteer and an active member of her church; and,

WHEREAS, Ms. McConnell is dedicated to empowering young adults and women in her community, devoting her time to nonprofits and community outreach organizations; and,

WHEREAS, Ms. McConnell has a graceful presence, her wisdom and knowledge is greatly appreciated, she is a joy to have in the office whether she is bringing in pies, telling stories about her children and grandchildren, or stylishly modeling the latest fashion, she indeed raises spirits with her presence; now therefore,
