Under the terms of an agreement, dated December 31, 1997, the day-to-day activities of the Jackson County Drug Task Force (JCDTF) are monitored by a Board (JCDTF Board) established under the JCDTF constitution and by-laws. The Director of Finance & Purchasing was authorized to make all payments required under the 1997 Agreement, provided funds for this purpose were appropriated in the then current Jackson County budget. The JCDTF Board has recommended and authorized the execution of a contract for the rental of a storage facility of property used by the JCDTF with Kent and Sue Ann Edmonson of Blue Springs, MO, at a cost to the County not to exceed \$11,100.00. The JCDTF requests the confirmation of this agreement for the period of January 1, 2013 through December 31, 2013. This is expense is included in the JCDTF budget.
