ADDENDUM TO AGREEMENT

THIS ADDENDUM TO AGREEMENT, by and between JACKSON COUNTY, MISSOURI, hereinafter referred to as "the County," and 12th STREET HERITAGE, 2124

E. 12th Street, Kansas City, MO 64127, a Missouri not-for-profit corporation, hereinafter referred to as "Organization," is made and entered into this ________ day of _________, 2012.

WITNESSETH:

WHEREAS, by Resolution 17810, dated January 30, 2012, the County and Organization did enter into an agreement whereby Organization agreed to provide drug prevention services, at a cost to the County of \$30,000.00; and,

WHEREAS, the Jackson County Drug Commission has recommended an additional funding allocation to Organization for its Re-Entry Program, at a cost to the County not to exceed \$12,500.00, for a total allocation of \$42,500.00 for 2012; and,

WHEREAS, by Resolution 17936, dated June 25, 2012, the County Legislature has authorized the County Executive to enter into this Addendum to Agreement:

NOW THEREFORE, in consideration of the mutual covenants and promises herein contained, County and Organization do hereby additionally agree as follow:

- 1. Except as hereinafter specifically modified, all of the terms of the prior Agreement between the parties dated March 13, 2012, shall remain in full force and effect and the terms and conditions thereof are incorporated herein by reference.
 - 2. This Addendum to Agreement shall be effective as of January 1, 2012, and

shall extend, with the original Agreement, through December 31, 2012.

- 3. The County shall pay Organization an additional funding allocation, at a cost to the County not to exceed \$12,500.00. One-quarter of this amount, or \$3,125.00 shall be payable upon the execution of this Agreement. The remaining payments shall be paid monthly in an amount equal to 1/12th of the 2012 contract amount **OR** expenses year-to-date, whichever is the lesser of the two.
- 3. This Addendum, together with the Agreement dated March 13, 2012, incorporates the entire understanding and agreement of the parties.
