3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, said the United Way Campaign kickoff is scheduled for Friday, September 17, 1999 with the 2nd Annual Employee Lock Up. Warrants will be served, arrests will be made, and co-workers will be locked up in a makeshift Jackson County jail which will be located on the front patio of the courthouse. There will also be a lunch of hot dogs, chips and a drink for \$2.00 which will also be donated to United Way.

On Thursday, September 16, 1999 Jackson County will have a Clean Out Your Files Day. The last time this was done in 1997 the County recycled 8 tons of paper. The goal this year is to recycle 10 tons. Employees are encouraged to dress down and participate in this recycling effort.

Last weekend Jackson County Parks and Recreation Department completed the coastal cleanup at county lakes.

Ms. Shields said that a representative from Peat Marwick will be present near the end of the legislative meeting to go over the audit which they just completed on the financial aspects of the Detention Center Annex. Terry Young, County Legislator, said she was disappointed that the County Executive went ahead with the audit and that the taxpayers are paying for duplicate services.

Katheryn Shields said Peat Marwick did a financial audit only at a cost of approximately \$20,000.00, but nothing was audited with regards to the Population Control issue.

Further discussion on the jail audit being performed by the State Auditor and the Legislative Auditor.

Discussion with Judge O'Malley and Robert Beaird, Prosecuting Attorney, regarding the Farris case and the electronic home device system.

Judge O'Malley said judges are faced with hard decisions under the federal court order to keep the cap down in the county jail. Judges are forced to release instead of being able to choose which inmates to release.

Robert Beaird, Prosecuting Attorney, suggested that a system be set up where the company monitoring the electronic home device would not only contact the State Probation and Parole office but also contact the Population Control Coordinator. The Population Control Coordinator would then notify Criminal A (Judge O'Malley) and a warrant would be issued. The Population Control Coordinator would then notify the local law enforcement so that the escapee would be picked up immediately and there would be no lag time.

Discussion regarding the Detention Center Annex opening 9 months late and being over budget. There was also discussion about the federal matrix system and the population control coordinator.

Ronald E. Finley, County Legislator, moved that the Legislature ask the State Board of Probation and Parole and the contractor of the electronic monitoring program to report to the Legislature on what occured regarding the monitoring of Mr. Farris. He asked staff to verify the information received in this report as to the effectiveness and provide their recommendations and input on the history and effectiveness of the electronic monitoring program. 2nd by Dan Tarwater.

Voice Vote. (APPROVED)

Jane McQueeny, County Counselor, asked Mr. Finley if when he referred to staff, if he meant the County Counselor's office or anyone in particular.

Mr. Finley said he prefers to use the generic word "staff" because that encompasses the financial evaluation of the effectiveness of the program (Is the expenditure worthwhile?) and also encompasses the staff of the program for whoever is supervising the contractor. He would like the County Executive or County Counselor to give the recommendation and present their findings to the Legislature.

Ronald E. Finley asked what would be discussed in the closed meeting.

Jane McQueeny said they would discuss the arbitration claims and also Ordinance #2960.

Katheryn Shields said that Jackson County needed to hire competent counsel to proceed with the arbitration which will begin in the next two weeks.

Dan Tarwater, County Legislator, said he thought the Legislature agreed that this would be paid by making payments and not by authorizing a lump sum up front.

Jane McQueeny stated that she needs the money to put in the proper line item of her budget so that bills can be paid when received. She said the contracts will be filed with the Clerk's office.

Victor E. Callahan, Chairman, said that he is in favor of appropriating the money to keep the law firm on a retainer and then pay as they go. He believes the taxpayers deserve a level of accountability.

Dan Tarwater suggested putting the money in an account where the Legislature has control instead of having the County Counselor in total control of the money.

Fred Arbanas, County Legislator, asked that the audit prepared by Peat Marwick be distributed to the Legislature today and be discussed at the next legislative meeting.

After some hesitation, Katheryn Shields agreed. She said she would rather give her report first and then distribute copies of the audit.

The Legislature did not have a closed meeting.
