5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, introduced Allan Gray to the Legislature who was hired last Monday as the governmental liaison. He will serve as a link between Jackson County and other community and governmental entities and civic groups. He is a native of Jackson County and comes from the Federal Reserve Bank where he was in the Department of Public Affairs. He is also immediate past chairman of the Missouri Arts Council, founder and Chairman Emeritus for the Kansas City Friends of Alvin Ailey, and advisor of the National Endowment of the Arts. He was active in Bi-State Amenities Tax Planning and served on the Governor's Commission for family and children services.

Victor E. Callahan, Terry Young and Katheryn Shields participated in the ribbon cutting of the I-70 and Selsa Road interchange which is the first step in the Little Blue Parkway extension in eastern Jackson County. State Farm and Blue Ridge Bank will build and also the city of Independence approved a plan for a hotel and convention center at this location.

This weekend there will be a re-enactment of a militia muster at Fort Osage. There will also be a dedication of a grave marker for 49 frontier army soldiers who died at the Fort. The marker is provided by the Veterans Administration. The dedication ceremony will be held on Saturday, October 16, 1999 at 1:00 p.m.

Also, on Saturday, October 16, 1999, we will have Dogtoberfest '99 at Kemper Outdoor Education Center at Fleming Park. Participants bring their dogs to participate in contests, games, demonstrations and prizes. There will also be a fundraiser for the parks and local animal shelters called Tails for Trails. The cost is \$12.00 in advance and \$15.00 at the gate to participate in this dog walk.

Ronald E. Finley, County Legislator, said Victor E. Callahan, Terry Young and himself met last Wednesday with staff of the Department of Corrections in Jefferson City at the request of Senator DePasco regarding the electronic shackling matter. The County Counselor, Director of Public Affairs and the Prosecuting Attorney were present. During the discussion the Legislature received information on how many people are currently working in this program. The staff of the Corrections Department advised them that the \$240,000.00 budget item for population control was used to pay four salaries of staff to monitor people on the pre-trial release. The legislators also found out that as part of this informal arrangement there was a contract being negotiated to formalize the arrangement and the budget. Mr. Finley said it is important that the pulic and the Legislature understand how we are proceeding with the State of Missouri on this issue. Information was also received that the number of people in pre-trial release has tripled over the last year. There are approximately 700 people in pre-trial release and 75 are on electronic shackling. Mr. Finley asked who was negotiating the contract and requested that the Legislature be kept informed on a weekly basis as to the progress on this matter.

Katheryn Shields said primarily the County Counselor has entered into discussions and they hope to have a Memorandum of Understanding, a contract or a memo from the County to the State indicating the amount we are spending and the minimal services we expect to receive for this payment.

Ronald E. Finley asked how long the discussions had been going on.

Katheryn Shields replied a couple of weeks, 2 to 3 weeks, within the last month.

Ronald E. Finley asked to be kept apprised of this situation. The Legislature made a motion a couple of weeks ago asking the County Counselor to communicate with the State and ask them to come and give us an explanation of what the procedures were in light of the Farris case. Mr. Finley has seen two letters written to the State but the State has not yet scheduled a time to meet with Jackson County.

Katheryn Shields said the State felt that they couldn't come then since the judge had issued a gag order. However, since the gag order is lifted we can again ask them to appear before the Legislature as a Whole or the Health and Justice Committee.

Victor E. Callahan said Jane McQueeny, County Counselor, contacted him Friday and extended an invitiation to the Legislature and he will talk with members of the Legislature to see if they want to have this discussion with the State during a Health and Justice meeting or before the Legislature as a Whole.

Katheryn Shields said she will ask the County Counselor to update the Legislature on a regular basis regarding the negotiations with State Probation and Parole.
