This Memorandum of Understanding: Addendum #2 entered into and effective this ^{Jan 1 2012} 11 day of December, 2011, by and among Jackson County, Missouri, and the Mid-America Regional Council, amends the original Jackson County/Kansas City Regional Alternatives Analysis Study Memorandum of Understanding effective January 28th, 2011 to reflect the following amendments specific to the Commuter Corridor element of the Regional Alternatives Analysis Study:

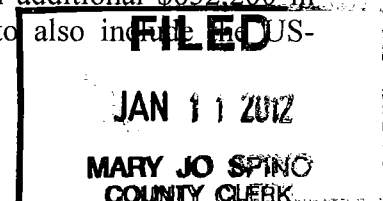
1. Modification of Section III C, Study Management Approach and Structure, Commuter Corridors, with modifications reflecting the addition of the US-71/Grandview Corridor Alternatives Analysis and the support of the Regional Transit Alliance. The modified paragraph appears below.
2. Modifications of Section V, Grant Budget and Local Match Commitments , subsections A & C, with modifications reflecting additional federal funds secured to support the completion of the US-71/Grandview Alternatives Analysis, additional local match commitments provided by the Three-Trails Community Improvement District, and the relative increase to MARC's administrative allocation. The modified paragraph appears below.

III. Study Management Approach and Structure

- C. Commuter Corridor Element – The Commuter Corridor element will support the assessment of the I-70, Rock Island, and US-71/Grandview commuter (commuter rail) corridors that will link with alternatives from the Downtown Corridor AA detailed above. This study element will be supported by the formation of multi-jurisdictional advisory team representing communities along both corridors and will be led by Jackson County with MARC serving as technical staff support. The Regional Transit Alliance will serve as a project partner and support stakeholder engagement and public education activities.

V. Grant Budget and Local Match Commitments

- A. Grant Budget and Local Match - The original federal grant award announced on December 21st, 2010, included \$1.8M in federal funds to support both the downtown corridor and commuter corridor elements of the original \$2M request, representing 90% of the original request. Jackson County, Missouri secured an additional \$652,200 in federal grant funds to expand the commuter corridors study to also include US-



71/Grandview Corridor. The grant budget outlined below is the final budget based on these two federal awards, estimated study cost, and authorized local match commitments.

C. Local Match Commitments- Jackson County, Missouri and the City of Kansas City, Missouri agree to provide a 20% local matching share on all federal funds as required by Federal Transit Administration and in a manner and allocation consistent with the agreed-to distribution as outlined in Figure I below. The Three-Trails Community Improvement District also commits to provide \$50,000 match in support of the US-71/Grandview Alternatives Analysis. Project partners have the ability and may choose to provide a financial share or amount higher than the minimum commitment if necessary to complete the study in a manner desired, and in a manner subject to local authorizations. Cost estimates for the related Alternatives Analysis studies are outlined below in addition to the authorized local match commitment from related jurisdictions.




